1	<b>QUESTION</b>	<u>Subject: Informative meeting</u> Is it obligatory for potential tenderers to attend the informative meeting or only voluntary?

2	<b>QUESTION</b>	<u>Subject: participation of tenderers:</u> In art. 8 of the procurement notice is not clear specified, whether participation is open to all nationalities worldwide, or whether they are any restrictions of eligibility. May we kindly ask you to name all countries explicitly, which are eligible for participation on this tender?
	<b>ANSWER</b>	As per art.8. of the procurement notice and art 3. of the Instructions to Tenderers of the Tender Dossier, there is no restriction on the nationality of the company.

3	<b>QUESTION</b>	<u>Subject: Deadline</u> Please, confirm, whether the submission deadline for tenderers indeed is an 19.10.2011 (leaving 30 days for tender preparation and submission), or the deadline is, as usual for EU tenders, for 2 month?
	<b>ANSWER</b>	Please, be reminded that the procedure, as per art. 2 of the Procurement Notice procedure, is "Local Open Tender". As per PRAG art.4.4 on page 75, paragraph 4 "In this procedure, there must be a minimum of 30 days between the date of publication of the procurement notice in the local press and the deadline for receipt of tenders." Thus, since it is Local Open Tender procedure 30 days of publication is applicable.
